85% Foreign Investment Venture Capital & Pharmaceutical

Foreign investors may own up to 85% of the shares in venture capital. In addition, pharmaceutical and financing industries are also widely opened for foreign investment providing 85% limit of ownership.

Which Opened and Closed

Foreign investors need to carefully assess which business sectors are opened with requirements and which are fully closed.

The business sector that is currently open to 100% foreign ownership in trade is the cold storage business, distribution affiliated with production, direct sales through network marketing, and brokers. In tourism and the creative economy, such as opening bars, cafes, restaurants and sports facilities.

While in the communication and information sector, there are investments involving an investment of Rp100 billion allowed for 100% foreign ownership. Others, in the energy and mineral resources sector, there is a biomass pellet industry for renewable energy that is open to 100% ownership.

100% Closed for Domestic & Foreign Investments Alcoholic Beverage & Casino


Currently, new investment in alcoholic beverage industry is not allowed for both domestic and foreign investors. It occurs since 1996.

In addition to the alcoholic beverage, casino industry and other 18 industries are not permitted; including marijuana cultivation and capture of fish species listed in CITES.
